During the course of the project, preliminary results were presented at various international conferences, the summary of which is given in Table 1. Other collaborations interactions took place with EMCDDA on indicators, in particular supply indicators. EMCDDA also intervened, remotely, at the final conference of the project related to Co-PI 2. Other interesting and useful interactions took place following the participation in the meeting day with discussion in Brussels in the framework of the European action plan on drugs: Cooperation and Collaboration for the Reduction of Demand and Supply. Given the low number (24) of participants, discussions and lasting interactions arose.

At national level, inter-institutional collaborations have taken place with all data sources of interest Agencies and have allowed the acquisition of all data necessary for the analysis of WP4 and WP5, detailed in Annex 2 and Annex 3 of the national report. In addition, a protocol was established with the Higher Institute of Health (Ministry of Health), which allowed for in-depth analysis of the data relating to the General Register of Mortality and SDO (hospital discharge), presented at the final conference of Co-PI 2 in Italy, which make it possible to plan scientific work and international publications. Other interactions at the national level with operators and organizations involved in assistance and harm reduction such as, just to give an example, Parsec, Villa Maraini, San Patrignano, CNCA, and Gruppo Abele.

A website, dedicated to the communication of the project's results, has also been set up, where the final conference, held online on 18 June 2020, was announced.
